- d. **Guidelines and Policies:** Belanger reported work on the library hours guidelines, which are about closings and holidays. They expect a draft perhaps in April.

- f. Ad Hoc Committee / Statute and Regulations: Garm shared that an early draft of rewritten regulations is being reviewed at PDE. The next step will be an exposure draft, hopefully in early 2024. While that goes on, Sharpe and BLD Team are working on clarifying documents. Discussion will continue and communications will be forthcoming so that the library field has a shared voice before future steps.
- Community Conversation Mellor talked about the process of communications for understanding potential changes to the regulations and discussed the transparency of the process, the forums that PALA has held, and other small and large group conversations.

11. Public Comment

- **a. Katherine Dannehl**, Pennsylvania Integrated Library System (PalLS) gave a brief update that the integration with Access PA will go live February 8. There are 160 libraries, and adding more soon, will be moving towards 200.
- **b. Maryam Phillips**, HSLC, explained that POWER Library completed fall training in 9 locations with 10 events. There is a new librarian's hub in POWER Library at https://librarians.powerlibrary.org/home.
- c. Christi Buker, Pennsylvania Library Association (PaLA), talked about the importance of communications to representatives and senators to ensure the library funding in the state budget could be distributed. Frontline Online registration is open. There will be a Friends and Trustees Institute on Saturday, March 23, 2024.

Governor's Advisory Council on Library Development Chair's Report December 7, 2023

Changing of the Guard

In 2024, we will say farewell to David Belanger, who has served as Vice Chair and Chair of the Guidelines Committee for many years. His dedication to Council, his wisdom and experience, and his ability to translate many opinions into coherent written guidance will be greatly missed. He has agreed to stay on until his replacement is seated, so we hope to have another meeting or two with him prior to his actual departure.

We also wish Sue Werner well, as she completes her term on Council. Sue joined us as a Trustee member, and her position on the Board of the Schlow Memorial Library is coming to an end, just as her first term here is ending. She came onto Council as the COVID-19 pandemic was beginning, and her time with us has mostly been virtual. We know that Sue will continue her important work with nonprofits in her hometown, including advocating for library services.

Later in the December meeting, we'll discuss changes in leadership for the Executive Committee and some standing committees. Our Council members, who are all volunteers, bring great value to this organization, and I truly appreciate their willingness to share their time and talent in the service of Pennsylvania's libraries.

Mansfield Funds

On November 8, 2023, HSLC officially became the depository for funds for the Rare Books Library. Since 2002, the money had been held by Mansfield University on behalf of the Governor's Advisory Council on Library Development (GAC). The transfer of responsibility for Rare Books funds was spearheaded by Sarah Greene, Bureau of State Library; Maryam Phillips, HSLC; and leadership of the GAC, along with State Librarian Sue Banks. The completion of the move was several years in the making, and it is gratifying to know that the money is now with HSLC.

Planning for 2024

Plans are underway to develop a special communication about Pennsylvania libraries to be shared with Governor Shapiro that will coincide with the Grand Reopening of the State Library of Pennsylvania in April. The Communications, Education and Advocacy, and Planning Committees will all have a hand in producing it.

Governor's Advisory Council Meeting Thursday, December 7, 2023

Deputy Secretary's Report:

- PDE OCL staff will be working with members of the OESE Curriculum development staff to produce content to share in preparation for the celebration of Pennsylvania's 250th anniversary of statehood. We hope to share our primary sources and unique materials through digital interfaces and locations that can support work in the classrooms and in libraries. We intend to have OCL staff present at next year's SAS Institute to introduce the resource collections and hope to introduce them widely thereafter.
- PA Humanities Declaration of Independence at 250 The Office of Commonwealth Libraries is partnering with PA Humanities in a National Leadership Planning Grant from the IMLS to pilot a program to convene conversations around the Declaration of Independence at 250 at the local level with libraries as hosts. The program will train local library leaders and partners to facilitate those convenings, with the hope that those conversations will help community leaders and activists to discover shared values and understanding for the future, as well as an appreciation of our past.



- **COSLA Update:** Five PA State Librarians met in Newport, RI at the 50th Anniversary celebration of Chief Officers of State Library Agencies. Deputy Secretary Banks, Glenn R. Miller, M. Clare Zales, Sara Ann Parker and Stacey Aldrich raised a glass to 35 years of service to the Commonwealth in the Office of Commonwealth Libraries.
- Master Plan on Older Adults Deputy Secretary Banks' representation of PDE on the planning committee for the Master Plan has resulted in a number of priority initiatives in the areas of Aging in

the Community, Education and Navigation and Unlocking Access – involving libraries at local level supporting aging populations in a wide variety of ways including volunteering, employment, digital navigators and digital literacy. All of the initiatives explored would expand the capacity of libraries to involve and serve those populations through an infusion of new financial resources from colleague agencies.

- PHMC and opening of the PA State Archives On the day after the GAC meeting at which this report will be shared, the new Pennsylvania State Archives building will be opened officially with a ribbon cutting on Friday, December 9, 2024. This is just the first of many changes to come for our colleague agencies within the Pennsylvania Historical and Museum Commission, on which Deputy Secretary Banks represents the Secretary of Education. More information to come on their plans and timelines.
- **Grand Reopening of the State Library of PA** Planning process continues for a day of celebrating the renovation and restoration of service at the State Library of Pennsylvania. We will have ceremonies and speakers, tours, exhibits and interactive programs that celebrate the Library and the history of libraries and librarians in Pennsylvania. We'll also celebrate and acknowledge the land on which the library stands and the communities that made way for this historic resource.
- New Regulations for Pa Code Title 22, Part IX. The first draft of the new language is being reviewed by PDE Policy and Legal. We feel confident that we will have a fresh edition of the draft ready to be circulated with stakeholders as the "exposure draft" for feedback. That feedback will then be used to make further edits, aiming to have draft language for submission to the Independent Regulatory Review Commission (IRRC). The goal is to be as sure as we can that there is nothing in the draft language that will be controversial enough to derail or delay the process of adoption of new regulations, once it's submitted to the IRRC.

- **Update on Cooperation with DHS:** DHS had received a grant to distribute Air Purifiers. Likely these will be released in 2024 for public libraries who submitted the online form as funding allows in priority order as shared in the Compendium. OCL will continue to share information as it is received.
- Broadband and Digital Equity Update: The Pennsylvania Broadband Development Authority is implementing the Commonwealth of Pennsylvania Statewide Broadband Plan and working towards Internet For All. BEAD (Broadband Equity Access and Deployment) Volumes 1 and 2 and the draft Digital Equity Plan are available for review. Libraries are encouraged to: 1) Provide comments to the Statewide Digital Equity Plan, 2) Consider plans to submit a Multipurpose Community Facilities Improvement grant proposal (guidelines were approved at the last board meeting and will be posted soon—grant period opens in January) 3) Continue to promote the Affordable Connectivity Program 4) Be a strong community anchor institution and engage and understand community internet needs while you build relationships with partner organizations and 5) Ensure your library has the fastest and most reliable internet connection with well-planned and future ready public access technologies and that staff are able to assist patrons with digital literacy needs.

FEDERAL FUNDING/PROGRAMS

LSTA

Statewide Library Service Grants

FY 2024-25 applications for new Statewide Library Service Grants will open in the spring of 2024. Applicants will have one (1) month to apply. Interested organizations are encouraged to view the Get Ready to Apply webinar on the PA Staff Academy. Grant guidelines, timeline, and other useful information can be viewed on the Statewide Library Services LibGuide. Awarded contracts will run from July 1, 2024-June 30, 2025.

Youth Services and Professional Development 2024 Local Library Grants

 FY 2024-25 applications for Local Library Grants specific to youth services and professional development will open in early 2024. Libraries interested in applying for local library grants are encouraged to get ready to apply before the applications open.

Youth Service

- The PA One Book Committee has chosen Slug in Love, written by Rachel Bright and illustrated by Nadia Shireen, as the 2024 PA One Book Early Literacy selection. The PA One Book program is entering its eighteenth year promoting the value and benefits of reading early and often to preschoolers.
- The Office of Commonwealth Libraries (OCL) is one of five state library agencies joining the IMLS grant-funded initiative <u>Building Equity-Based Summers</u> (BEBS) Through Libraries & Communities to equip library staff to create summer programs and services that are equitable and promote equity across the communities served by their library. OCL is seeking five public libraries that possess the drive, commitment, and capacity to sustain transformational change to summer services through an eight-week virtual work group. Interested libraries can view more information <u>here</u>. The application closes on Monday, December 18, 2023.
- The youth services advisory team selected candidates for the Pennsylvania Summer Library Program 2024 Showcase on the <u>PA Staff Academy</u>. Selections were based on responses to the Pennsylvania Summer 2023 Impact Report. The 2024 Showcase will feature early childhood, school age, young adult, and intergenerational programs in addition to ideas for the "<u>Adventure Begins at Your Library</u>" 2024 program theme. The 2024 Showcase will be accessible mid-Winter 2024.

Professional Development

- To ensure OCL is investing in statewide training that is relevant to the needs of the library community, a <u>Professional Development Recommendations</u> form is available.

 - Performance Management in 5 Parts
 - Project Management for Nonprofits
- The <u>3-part Readers Advisory workshop series with Becky Spratford</u> is also now available on the <u>PA</u> Library Staff Academy.

STATE FUNDING/PROGRAMS

Regulations, Policy, and Guidelines

- While regulatory draft documents are under PDE review, the internal regulations work group continues to meet weekly. The current task is to prepare supporting documents for clarification.
- BLD is working with PDE Policy on developing a comprehensive arrangement for policy and guidance documents.
- Committee work continues on updating the library closings and holidays guidelines.

State Aid

- The PA General Assembly hasn't passed the enabling legislative language necessary for OCL to make FY23-24 public library subsidy payments; therefore, district library center aid hasn't been processed.
- The State Aid Library Subsidy Application (SALSA) closed October 1st. Reviews are complete, and approval emails were sent on November 27. The Plan for State Aid for Public Libraries & Federated Systems report opened on October 30 and closed on December 1st. Reviews of completed plans are already underway.
- Libraries are encouraged to review their listing on the <u>Public Library Directory</u>. Updates/Changes should be submitted via this form. The Library Status Form on Power Library is no longer available.
- Plans for State Aid for Statewide Library Resource Centers are open and will close on December 7th.
- The Annual Report PA Public Library Data Survey on LibPAS will be disabled for updates on Friday, December 8, 2023.

Keystone Grants for Public Library Facilities

• The 2024 grant round application closed in October. Twenty-one applications were submitted requesting nearly \$5.3 million in Keystone funding. The review process will conclude in mid-December, and applicants are expected to be notified in February. Awarded contracts will run from April 1, 2024-September 30, 2025.

GAC, Bureau of State Library Report December 7, 2023 Meeting

Forum Move is Complete!

The State Library's move back into the Forum Building was complete as of November 10th. All the newspapers and microfilm have been returned and placed in the new high density shelving areas. All the books, except for a section of the 800's, have been returned and reshelved. Due to a loss of stack space during construction some of the books in the mid to late 800s have had to be stored in a DGS warehouse in Mechanicsburg, PA. The staff are working on a plan to shift the collection to reintegrate these items.

All State Library staff have moved into their new workspace at the Forum Building. Everyone is working on finishing the setup of the Main Reading Room and the new Digitization Lab. The rest of OCL and PDE has fully moved into the building also.

The State Library plans to reopen on Tue, January 9, 2024. This date was pushed back at the request of the Department of General Services to accommodate the installation of door hardware that secures the building stairways. When the Library reopens, we will resume our previous hours of Tue 10-4, Wed 10-8, Thursday 10-4.

Staffing Update

Sarah Stegall has been hired as the new Library Assistant 2 for Public Services. Sarah graduated from Clarion University with a Bachelor's degree in Library Science. She previously worked at the Dauphin County Library System McCormick Riverfront Library. She is excited to join the team at the State Library and serve our patrons and politicians. Her personal interests include creating digital art, discussing media she enjoys with friends, and writing short stories when she has the time.

Michael Lear has been promoted to Librarian Supervisor 1 for Rare Collections. Michael has been with the State Library for 4 years and in that time has done a tremendous amount of work developing and promoting Rare Collections.

The State Library has been able to add a new position to the complement. It will be a new Library Assistant 2 position for Rare Collections. The position will work with the Rare Collections team and be responsible for the day to maintenance of the State Library Newspaper Collection. If you are interested, please watch for the job announcement coming soon.














