- 8. Council Vacancies: Garm discussed reappointment for Everton and Mackley and the need for two new members to replace recently retired members in the trustee and layperson role. Attendees are encouraged to send recommendations to Garm.
- 9. Guidelines on Service Areas: Belanger shared that the committee has been working diligently for months on a draft of a complicated guideline. OCL is suggesting members

for a focus group to review and react to the first draft created by the committee. After feedback, the committee will fine tune the guidelines and intend to present for approval.

- 10. Strategic Plan Update: Zaborowski shared an overview of discussion to address the priority areas of Communication, Collaboration, and Clarification. Plans include perhaps a small GAC group meeting with Secretary of Education twice a year, seeking an opportunity to meet with the Governor, sharing an annual update in a concise format or with an infographic to try to highlight, and a welcome letter. GAC attends PSLA and PALA. GAC will reach out to PCBL to get feedback because they represent Friends groups. GAC will reach out to college and research division of PALA and plan to establish a regular meeting with district consultants. GAC will engage library schools in PA to talk about trends and get feedback on issues.
- 11. Statue and Regulations Committee: At each GAC meeting going forward, Garm will give an update of what is happening with working group. The group is meeting monthly, reviewing progress on three fronts: (1) Internal process: Banks is leading the internal process by talking with Policy Director and looking for a project manager/regulations writer. (2) Communications: PALA is offering forums to gather feedback. At each of those Christi has presented survey questions and asked people to vote and then discuss it. They are having meetings with directors, district, and system folks. First survey asked if they agreed with decision to focus on regulations instead of statute. 80% agreed it was correct decision. (3) Regulations: Sharpe and BLD staff are working on structure and timeline for reviewing. The plan is to rewrite rather than revise the regulations. There is a need to focus on the future of PA libraries and what is possible rather than re-writing what was there. People need to understand that it won't be a quick process.

### Governor's Advisory Council on Library Development Chair's Report February 2, 2023

### Appointment of Vice Chair and Member-at-Large for Executive Committee

Our bylaws require annual confirmation of the appointment of the Vice President, as well as election of a Member-at-Large to serve on the Executive Council. The Executive Council consists of the Chair, the Vice Chair, a Member-at-Large, and the Deputy Secretary/State Librarian. I recommend that we re-elect David Belanger as Vice Chair and Allison Mackley as a representative to the Executive Council. David currently serves as Chair of the Guidelines Committee; Allison serves as Chair of the Bylaws Committee.

### **LibGuides**

The GAC Highlights publication has a new home as a LibGuide, thanks to the efforts of OCL Executive Assistant Carrie Cleary and GAC member Beth Mellor.

The LibGuide will contain issues of Highlights, along with documents and other materials referenced during GAC meetings. The Highlights publication is produced shortly after each GAC meeting. It contains notes on the meetings, but is not intended to serve as minutes. It allows the Council to more quickly distribute information prior to the formal acceptance of minutes at a subsequent meeting. <u>https://pa-gov.libguides.com/GAChighlights</u>

Carrie has also created another LibGuide for exclusive use of Council. It will serve as a repository for Council and committee documents and other items.

### Statute and Regulations Working Group

There will be a report on the progress of this group later in the meeting. However, I would like to express my appreciation to all members of the group for their willingness to meet regularly and collaborate on this important project to revise and update the state's library regulations. We have developed tasks and a timeline for the first six months of 2023, and, at this point, the group is on track for success. We anticipate that the full process will take as much as two years to complete.

### Vacancies and Appointments

There are currently two vacant seats on Council due to the resignations of Larry Nesbit and Patrick Oates. We are now seeking and interviewing candidates for a Trustee seat and a Layperson seat. We welcome suggestions for consideration.

In addition, we are awaiting word from the new Governor on the reappointment of two existing members.

# **Deputy Secretary's Report:**

- PDE New Secretary of Education, <u>Dr. Khalid Mumin</u> has begun his tenure. He has shared a message for PA libraries which we distributed via the mailing lists and the Compendium. We welcome any insight from the library field on Dr. Mumin or Gov Shapiro that we can put to work within PDE!
- COSLA Update: Update from Arkansas and South Dakota on new legislation gaining momentum in those states... <u>AR Legislation</u> about "obscene materials"; <u>SD Leg SB</u> and <u>HB</u>
- Digital Skills Training and Digital Equity input requested ALA and the IMLS working with the US Department of Labor to collect information. <u>More info</u> and links to the collectors via OCL's Compendium.
- Forum schedule update Progress continues at the previously-reported rate we hope to return to the Forum offices by late summer of 2023. State Library re-opening is tentatively scheduled for October of 2023 (after the PaLA Conference).
- We've convened some planning conversations about a Futures Community of Practice, with the help of a team of folks from libraries across the state – public, academic, school and special libraries. Look for invitations to join the conversation and community later this month or early February. The CT State Library has secured another Laura Bush 21 C. Librarian training grant to continue the work with the Kedge Futures School which has trained more than 60 PA Librarians in the tools of strategic foresight and futures work.
- Work continues on the process to produce new Regulations in Pa Code Title 22, Part IX. The OCL team is making good progress based on the work done by previous attempts to clarify our current Statutes attempting to start fresh with new language, rather than trying to revise the existing regulations, many of which date to the 1960s. Additional information on that process, which will involve discussions and feedback from the field, to come. The writing of the regulations is the responsibility of the Office of Commonwealth Libraries.




Save the date! Our annual meeting will be on 5/16/23, with committee events the first two weeks of May.

# Bureau of Library Development Report

Governor's Advisory Council Meeting February 2, 2023

### FEDERAL FUNDING/PROGRAMS

### LSTA

- Federal fiscal year 21/22 wrap-up and reconciliation continues. Financial and narrative reports to be submitted to the Institute of Museum and Library Services (IMLS) are being finalized.
- FY22/23 project highlights include:

#### **School Age Services**

- Video Game Clubs of America (VGCUSA) for Pennsylvania School Libraries- Nineteen school librarians, media specialists, and teachers applied and were invited to be part of the third year of Video Game Clubs of America (VGCUSA) for Pennsylvania School Libraries. The cohort members will receive a gaming kit, a technology kit, and a Padcaster Studio kit to provide opportunities for social and emotional learning embedded in STEM activities. VGCUSA founder and CEO Josh Bound, along with Director of Tabletop Gaming Max Jamelli and VGCUSA Student Ambassadors, will share promising practices on launching gaming clubs and supporting young learners and leaders.
- Pennsylvania Summer Library Program 2023 Showcase- The Pennsylvania Summer Library Program 2023 Showcase will be available on the Pennsylvania Staff Academy in the very near future. The purpose of this showcase is to highlight Pennsylvania library staff who made an impact on their communities with exemplary and innovative programming. Librarians and library staff will have access to information on a number of Summer library programs developed by Pennsylvania library staff from across the Commonwealth. Guest speakers share their expertise with you on their programming experiences from Summer 2022, what they achieved and, most importantly, the "why" behind their work. The Youth Services Advisory Team also has prepared a special presentation of the 2022 Summer Impact Report and information of outcomes, and equity, belonging, and inclusion. This showcase may be used for continuing education (CE) credits.
- Promising Practices for Youth Services in Pennsylvania's Public Libraries- The Promising Practices for Youth Services in Pennsylvania's Public Libraries guide will be available on the State Library of Pennsylvania's LibGuides in the very near future. The guide provides an overview of the skills and knowledge necessary for youth services professionals to provide excellent library service to youth from birth through age 18. The guide is intended to be a tool for both the staff providing services to youth and teens and the administrators leading the direction of library service. Through two phases of work performed by a dedicated committee, each promising practice was carefully reviewed through an equity, belonging, and inclusion lens to ensure that libraries are providing the most excellent and equitable library services to everyone in their communities. #### Early Childhood Services

 Recipients of two Early Childhood Services projects have been selected. Twenty libraries will be joining the 2023 Play and Grow cohort, which provides training and resources so library staff can create meaningful and impactful programs for children ages 0-5. Six libraries will receive training and funding to become part of the national Family Place Libraries network. This project is designed to transform libraries into community centers for early literacy & learning, parent education and engagement, family support and community connectivity helping to ensure all children enter school ready and able to learn.

- The application period recently closed for the StoryWalk project. This competitive award will provide funding to selected libraries as they develop literacy enriched activities and ideas that build children's interest in reading while encouraging healthy outdoor activity and family engagement. Selected libraries will be notified in February.
- The PA One Book Committee has chosen Mel Fell by author Corey R. Tabor as the 2023 PA One Book Early Literacy selection. The Pennsylvania One Book program is entering its eighteenth year promoting the value and benefits of reading early and often to preschoolers. #### **Adult and Special Populations**

Four virtual sessions of Including You will be offered in 2023. Each session is an interactive six-week workshop series designed especially for library staff that focuses on communication strategies to establish inclusive work and community environments. These opportunities are open to library staff at all levels and in public, academic and school libraries. New this year, public library trustees are invited to participate in some sessions. ### STATE FUNDING/PROGRAMS

#### State Aid

- State aid payments are expected to post on February 1, 2023. A few payments are delayed due to outstanding audits.
- The Annual Report PA Public Library Survey opened for data entry on January 27, 2023. All stateaided public libraries are required to complete this report. The data collected will be shared with the IMLS to be included in the national Public Library Survey and will be used to determine compliance with standards related state aid. Libraries are encouraged to use the information to assist with telling their library story to their communities and funding agencies.
- Regulations, guidelines, and policy:

- Public Library Directory Public libraries were sent a survey to ensure records are accurate. After those updates are made and a few remaining design changes, the directory will be ready to go live.

### GAC, Bureau of State Library Report February 2, 2023 Meeting

### Rare Collections Library (RCL) Report to GAC- October 1, 2022 to January 31, 2023

Ongoing construction in the Forum building has continued to impact the Rare Collections Library. Since the last report, steam (necessary for dehumidification) has been restored to RCL and planning continues for the replacement of the defunct water-mist fire suppression system and upgrades to other fire detection and suppression systems in rare collections areas. Due to a planned shutdown of the main chiller plant this February, there will be a solution implemented to keep the Rare Collections chiller operating during this time and during future annual shutdowns.

Rare Collections activities have included, cataloging new items, answering research requests, planning for returning to the Forum Building, and presenting the online talk *The Magazine: Purveyor of Literature, Taste, and Current Events* in November.

### **PUBLIC SERVICES**

In 2023, the State Library celebrates its 165th year as a Federal Depository Library. Due to construction, a celebration will be planned in 2024. The staff of the State Library participated in the program sponsored by the PA House Democratic Caucus to teach Caucus Fellows about the State Library and the services it offers. Kathy Hale and Katy Vance attended the presentation ceremony at the capital. The State Library has received many interesting questions such as looking for words to be included in the Oxford English Dictionary, looking for a bootlegger who lived in the Williamsport area, helping a patron looking for a post office in Lycoming County that only existed from 1901-1905, voter registration statistics from Montgomery County for 1940, and information about a cemetery in Butler County that was flooded out in 1985. Genealogy Librarian, Amy Woytovich, participated in the PALA poster session. New collection additions include over 300 new books with an emphasis on authors and subjects of people of color and mental health issues and subscriptions to Newspapers.com and American Chemical Society online database.

State Library staff and the director met with the Bosler Library director and staff to discuss the Cumberland County Municipal Law Library which is part of Bosler Law Library.

### **COMMUNITY ENGAGEMENT**

The State Library provided 33 programs between October 2022 and January 2023 and had a total of 627 participants. Programs included:

### DIGITAL COLLECTIONS

The Digital Collections staff have been working with PDE procurement on an RFP for a digital asset management system, a digital preservation system, and a web archiving system. These systems are a critical component of providing and preserving the State Library's digital collections and will hopefully be in place by Summer of 2023.

Staff are acquiring more digital state publications directly from state agencies in preparation for posting to our public access content management system.

The State Library of Pennsylvania is participating in the Community Web program through Archive-It. This program collects the web presence of local community groups and organizations and preserves these websites for the future.

Pennsylvania includes a wealth of diversity, and the State Library of Pennsylvania would like to capture as much of that diversity as we can. To that end, we are asking for your help.

The public libraries across the Commonwealth know their users and communities well. Help us find the local history organizations, minority communities, religious organizations, ethnic subcultures, LGBTQ+ information, environmental groups, hobby clubs, and others in your area.

# Report for Governor's Advisory Council

### PSLA Work with the LSTA Grant

PSLA is hosting a "One Book, One Association" event. The book featured is Our Story Begins, which features authors and illustrators who share their initial journey as artists. Our Conference Keynote Author, Alex Gino, is a featured author. Our hope is to reconnect with the joys and excitement of how we all joined this profession as school librarians. Ultimately, we wish to synergize our members in an effort to build community. Our kick-off event will be February 21, 2023, and there are 100 registered members.

On March 2, 2023, PSLA will partner with Library Journal / School Library Journal Professional Development to deliver a 2-hour webinar, Resisting Book Bans: A Crash Course to Defend Intellectual Freedom. The focus will be tangible ways to handle censorship, tips for finding allies and building coalitions, tactics for school board meetings, and strategies to ensure your library policies are up to date, and how to appropriately defend intellectual freedom.

On Thursday, March 30, 2023, our pre-conference workshop will feature our Intellectual Freedom Coordinator, Beth Shenefiel, and Joyce McIntosh from ALA's Office of Intellectual Freedom. They will co-host our 3-hour workshop, Beyond Banned Books: Intellectual Freedom in School Libraries.

### **PSLA Annual Conference**

The PSLA Annual Conference is scheduled for March 30-April 1, 2023, in Harrisburg, PA, with the theme of "Breaking Boundaries, Creating Communities." We are looking forward to seeing the GAC members at our PSLA Advisory Council Luncheon Meeting that will be held on Friday, March 31, 2023, from 12:30 pm until 2:00 pm in the Governor Room. Plus, we are excited to host the Governor's Advisory Council on Library Development Open Forum which will be held on Friday, March 31, 2023, from 3:30 PM - 4:30 PM. Invitations will be sent soon.

### **PSLA Advocacy Efforts**

Our Advocacy committee and Intellectual Freedom Task group have been extremely busy supporting our school librarians, school library programs, and our students. PSLA's Intellectual Freedom Task Group (IFTG) has created a website to raise awareness and help PA school librarians navigate these challenges. The website includes information about what to do when faced with a challenge, proactive steps to take before a challenge happens (including information about pending legislation that would impact PA school libraries), and resources about intellectual freedom issues. The IFTG has also established the Rapid Response Team to support PA school librarians who are facing challenges to intellectual freedom. When requested, Rapid Response team members will contact that school librarian to provide advice, help them prepare for the challenge, and support them throughout the entire process. These services are for all PA school librarians, regardless of membership in PSLA.

PSLA's advocacy used to focus on job security. Now it is fighting organized efforts that are attacking our students' rights to read diverse books, their intellectual freedom, as well as our professional practices.

POWER Library is seeking members of the public to participate on an evaluation team for a new online platform to make POWER Library electronic content available to the public. This new system will provide the web access for viewing the e-resources (databases and e-books) in POWER Library.

## What will be asked of you?

Evaluators are asked to view a live online vendor demonstration of the platform, and then to complete a brief survey.
